CASE SUMMARY

Claimant alleged failure to execute, breach of fiduciary duty, negligence, and breach of contract.
The claim arose out of the purchase and sale of S&P 500 options.

Respondent Morgan Stanley Dean Witter Online, Inc. denied the allegations of wrongdoing set forth in the Claimant's Statement of Claim.

RELIEF REQUESTED

Claimant requested \$62,838.90 in compensatory damages, \$35,000.00 in punitive damages, expert witness and attorney's fees, interest, and sought reimbursement of costs. Claimant amended the Statement of Claim to request \$300,000.00 in punitive damages and \$20,000.00 in attorney's and expert witness fees.

Respondent requested dismissal of the Claimant's Statement of Claim in its entirety, and reimbursement of costs and attorney's fees.

OTHER ISSUES CONSIDERED AND DECIDED

On March 21, 2001, NASD Dispute Resolution, Inc. received notice that the Arbitration Panel dismissed with prejudice Judith Rosenberg.

Respondent Judith Rosenberg did not file with NASD Dispute Resolution, Inc. a properly executed submission agreement but is required to submit to arbitration pursuant to the Code and is bound by the determination of the Panel on all issues submitted.

The parties agreed that the Award in this matter may be executed in counterpart copies or that a handwritten, signed Award may be entered.

AWARD

After considering the pleadings, testimony, and evidence presented at the hearing, the Panel decided in full and final resolution of the issues submitted for determination as follows:

- 1) Respondent Morgan Stanley Dean Witter Online, Inc. is liable to and shall pay Claimant \$62,838.90 in compensatory damages.
- 2) Claimant's request for interest is denied.
- 3) Claimant's request for punitive damages is denied.
- 4) Each party shall bear its own costs, including attorney's and expert witness fees.
- 5) All other relief not expressly granted is denied.


