Claimant, The Moran Fund LP, signed the Uniform Submission Agreement: October 9, 1999

Statement of Answer filed by Respondent, Discover Brokerage Direct, Inc., on or about: March 19, 1999

Respondent, Discover Brokerage Direct, Inc., signed the Uniform Submission Agreement: March 19, 1999

CASE SUMMARY

Claimant alleged that its account suffered damages with respect to Claimant's day order to buy 10,000 shares of Boeing Co. stock at 43 11/16 on margin and further alleged that Respondent is liable for the losses sustained in Claimant's account.

Respondent alleged that on November 23, 1998, Claimant placed an order to buy 10,000 shares of Boeing Co. stock at 43 11/16, good for the day. Respondent further alleged that the market maker to which the order was sent filled the buy order at the limit price that day and alleged that the fill was not reported back to Discover Brokerage until November 25. Respondent further alleged that Discover Brokerage immediately notified Claimant that the order had filled. Respondent further alleged that Claimant cannot avoid the consequence of its investment decision because of a late report and further alleged that Claimant has failed to mitigate its alleged damages.

RELIEF REQUESTED

Claimant's Claim requested compensatory damages, interest and punitive damages totaling \$238,445.00.

Respondent requested that Claimant's Claim be dismissed in its entirety; that all costs and expenses of this arbitration be borne by Claimant; and for such other and further relief as is equitable under the circumstances.

OTHER ISSUES CONSIDERED AND DECIDED

On or about September 14, 1999, the parties agreed that The Moran Fund LP is the Claimant in this matter instead of Amedee D. Moran.

The parties have agreed that the Award in this matter may be executed in counterpart copies or that a handwritten, signed Award may be entered.

AWARD

After considering the pleadings, the testimony and evidence presented at the hearing, the Panel has decided in full and final resolution of the issues submitted for determination as follows:

1. Respondent Discover Brokerage is liable for and shall pay to Claimant The Moran Fund LP the sum of \$23,125.00, in satisfaction of Claimant's claims.
2. Claimant's claim for punitive damages is denied.
3. The parties shall each bear their respective costs including attorney's fees.

FEES

Forum Fees and Assessments

The Panel assesses forum fees for each hearing session conducted. A hearing session is any meeting between the parties and the arbitrator(s), including a pre-hearing conference with the arbitrator(s), that lasts four (4) hours or less. Fees associated with these proceedings are:

One (1) Pre-hearing session with Panel x \$750.00 = \$750.00
Pre-hearing conference: September 14, 1999 1 session

Two (2) Hearing sessions x \$750.00 = \$1,500.00
Hearing Date: December 20, 1999 2 sessions

Total Forum Fees = \$2,250.00

1. The Panel has assessed \$1,125.00 of the forum fees to Claimant.
2. The Panel has assessed \$1,125.00 of the forum fees to Respondent.

Administrative Costs
